- 4. The Human and Civil Rights, Communications, Instructional Excellence, Education Support Professional, Collective Bargaining, Forces on Education, Friend of Education, and Gene Rochelle Political Activist Awards will be presented at an awards ceremony at Delegate Assembly.
- 5. The Human and Civil Rights Committee will review and recommend nominations for the Human and Civil Rights Awards.
- 6. The Communications Committee will review and recommend nominations for the Marshall Gregory Awards.
- 7. The IPD Committee will review and recommend nominations for the Instructional Excellence Awards.
- 8. The OEA Education Support Professional Committee will review and recommend nominations for the Education Support Professional Award.
- 9. The Collective Bargaining Committee will review and recommend nominations for the Collective Bargaining Award.
- 10. The Forces On Education Committee will review and recommend nominations for the OEA Advocate for Academic Freedom Award.
- 11. The OEA Board of Directors will select the OEA Friend of Education, the Claude A. Dyer Memorial Awards, Gene Rochelle Political Activist Award and OEA Outstanding Legislator Award.

- 1. Demonstrates a concern for the well-being of Association members through the advocacy of members' rights.
- 2. Demonstrates a commitment to advance the Association.
- 3. Demonstrates professionalism through attitude and action.
- 4. Recognizes responsibility to assist others in their growth toward an increased level of Association advocacy.
- 5. Promotes the improvement of the profession by efforts within the education community and the general public.

ELIGIBILITY REQUIREMENTS:

- 1. Must be an OEA member or an OEA Local Association.
- 2. Nomination must be submitted by the Zone Chairperson.
- 3. Three (3) letters of recommendation must be submitted.
- 4. Nomination forms, letters of recommendation, support material and Support Materials Form must be submitted in accordance with the timelines for OEA Awards.

Letters of nomination should include circumstances which qualify the individual or Association for the award. Three (3) letters of recommendation are required, including one from the OEA Zone level and two from other individuals or agencies with first-hand knowledge of the activities involved.

CRITERIA:

- 1. Demonstrates a commitment to equal educational opportunity.
- 2. Participates in a significant manner in initiating or developing equitable policies affecting student academic success.

ELIGIBILITY REQUIREMENTS:

- 1. Must be an OEA member, an OEA Local Association, or other group of OEA members.
- 2. Nomination must be submitted by a Local Association President, a Zone Director, or a Zone Chairperson.
- 3. Three (3) letters of recommendation must be submitted.
 - a. Letters of recommendation should include circumstances which qualify the individual or Association for the award.
 - b. Three (3) letters of recommendation are required, including one from the Zone level and two from other individuals or agencies with first-hand knowledge of the activities involved.
- 4. Nomination forms, letters of recommendation, support materials, and Support Materials Form must be submitted in accordance with the timeline for OEA awards.
- 5. Cannot have been a recipient in the previous five (5) years. (Record of previous recipients of the award will be maintained by the OEA.)

GLENN SNIDER HUMAN RELATIONS AWARD

DEFINITION:

Presented to the school district, individual or organization best exemplifying the practice of effective human relations and concerns for human rights. May be accompanied by a monetary award to be funded by the interest from the Glenn Snider Fund.

CRITERIA:

- 1. Demonstrates a concern for the well-being of human beings.
- 2. Demonstrates a personal commitment to equal educational opportunity for all constituents of the school community.
- 3. Demonstrates an in-depth knowledge of human relations problems, particularly those pertinent to the situation.
- 4. The Glenn Snider Award will be presented to a school district, individual or organization and may be accompanied by a monetary award, to be funded by the interest from the Glenn Snider Fund.
- 5. Discourages stereotyped ideas, concepts, and expressions when they are damaging to good human relations by pointing to the worth, dignity, and uniqueness of every individual regardless of race, sex, religion, or socio-economic background.
- 6. Recognizes that the school, individual or organization, operates in the changing social order, that it must deal effectively with all groups, and that public education in America must be the agency through which the changing social order can be refined and made more meaningful.
- 7. Recognizes responsibility to assist others in their growth toward a higher level of positive human relations.

ELIGIBILITY REQUIREMENTS:

- 1. Must be an Oklahoma school district, individual or organization.
- 2. All nominations must be endorsed or submitted by the local Association.
- 3. Three (3) letters of recommendation must be submitted.
- 4. Nomination Forms, letter of recommendation, support material and Support Materials Form must be submitted in accordance with the timelines for OEA Awards.

DESCRIPTIVE UNIT ABSTRACT REQUIREMENTS

The purpose of the descriptive unit abstract is to include pertinent, supportive data documenting the unit's success and its implementation in the classroom or impact on teachers. Please include samples of the process, descriptions of activities used, and samples of evaluative techniques utilized.

Unit will be evaluated as follows:

- 1. General Statements (maximum of 1 page) 10 points
 Include title and purpose of unit, audience served and significance for teachers or students
- 2. Unit Objectives (maximum of 1 page)List specific expectations/desired outcomes
- 3. Activities and/or Projects (maximum of 3 pages)

 Must be relative, innovative, creative, appropriate

- 4. Adaptability (maximum of 2 pages) 25 points
 Adaptability to other grade levels, individual student needs, curriculum areas or in-service education
- 5. Method(s) of evaluation (maximum of 1 page) 15 points
 - 1) Describe criteria used to measure effectiveness of unit
 - 2) Describe evaluation tools utilized (including but not limited to tests, contests, student projects, student or teacher evaluation, school and/or community impact)
- 6. Resource Material (maximum of 1 page) 10 points
 Identify personnel, print materials, audio/visual equipment, and any other materials necessary
 Document original material
 Cite commercial materials/resources

PURPOSE:

Presented by the Board of Directors of the Oklahoma Education Association, the award honors a person or organization whose contribution to the safeguarding of academic freedom has had a significant impact on the public schools in Oklahoma and in the nation.

QUALIFICATIONS:

The Advocate for Academic Freedom Award may be bestowed upon any person or organization whose leadership and activities in the state have proven that the person or organization has defended the rights of teachers and public education and the belief in academic freedom in an exceptional manner.

NOMINATIONS:

Any member of the Oklahoma Education Association may nominate a recipient by completing a nomination form which can be obtained from any member of the OEA Board of Directors. A screening committee composed of the members of the Forces on Education Committee shall review each nomination. The committee shall submit its recommendation for the Award to the OEA Board of Directors for approval.

THE AWARD:

The Advocate for Academic Freedom Award will consist of an engraved plaque. The award will be presented by the OEA President or designee at the annual OEA Delegate Assembly in a ceremony designed to place emphasis on the importance of the award.

MARSHALL GREGORY AWARDS

DEFINITION

The Marshall Gregory Awards recognize professional and high school student reporters and broadcasters and their newspapers, websites, radio, and television stations for excellence in accurate, positive coverage of public schools, education issues, the education process and/or the Oklahoma Education Association.

WHO SHOULD ENTER

- Professional journalists at Oklahoma media outlets who are covering education events or issues that affect teachers and students in Oklahoma public schools.
- High school students who are writing, editing, producing, or photographing education events or issues for their high school publications, television or radio programs, or as freelance writers/producers for professional media outlets.

Awards will be presented to the person who writes the story, shoots the pictures, or edits the publication, as is appropriate for the category entered. Media outlets may be the recipients of awards for a series of articles or programs, but not for individual stories or photos. Student awards are presented to the students who produce the work, not their publication or program advisors or sponsors.

ENTRY CRITERIA

Winning entries will have focused on positive coverage of public education, the education process or a specific education event or issue. (Note to student entries: The Marshall Gregory Awards program is not a general journalism contest. Your entries must cover education issues, events, or the education process. Those entries not meeting these criteria will not be judged.)

Nominees may submit only one entry per category.

Awards may be given to journalists working for print publications and websites, radio or television reporters, editors, photographers, videographers, producers, or media outlets in the following categories:

News stories

Entries should fairly and accurately report a current education event or issue.

Feature stories

Entries should provide a creative, in-depth look at an education event or issue. The topic may be somewhat timeless but could also be about a timely event or issue.

Series

Entries must include at least three stories in a series connected by topic or theme. Each printed story should each include some kind of reference to the series.

Special publication or program

Entries are one-time publications or television or radio programs that cover a particular education issue in-depth or cover a wide variety of education issues creatively and interestingly.

Editorials

Entries are works of opinion that support, promote and/or enhance public education or a particular education event or issue.

Photography/Videography

Entries are photos or video that creatively help tell a news or feature story on an education event or issue in a printed publication or in a televised program.

Exceptional Year-Round Coverage

This category recognizes year-round examples of excellence in reporting education issues. Entries should include 4-6 stories in different issues or from different broadcasts from throughout the year that demonstrate a continuing commitment and excellence in education reporting. Awards of Excellence may be given in all media categories for year-round excellence in

- news stories.
- feature stories,
- editorials (opinion), and
- photojournalism (still or video)

Special Awards

Special awards may be given if the quality of coverage is deemed so outstanding as to warrant special recognition. Awards are given at the discretion of the Communications Committee, with approval of the OEA Board of Directors.

WORK SAMPLES

Each entry must include a sample of the work being submitted. All entries should be emailed to okeaawards@gmail.com.

- Print entries email a PDF copy of the entry or provide a link to the article online. Website entries submit a direct link to the article.
- Television entries submit a direct link to the entry online or include a file that is playable in Microsoft Media Player.

GOLDEN APPLE AWARDS

DEFINITION:

The Golden Apple Awards recognize OEA local Associations for their consistent efforts to provide quality communications to all of their audiences, including members and other education personnel, local school administration, parents, and the community in general.

ELIGIBILITY:

Any active local affiliate of the OEA is eligible to enter its communications efforts for judging. Emphasis in selecting recipients will be placed on consistent, quality communications produced or conducted by its members.

CRITERIA:

Entries may be sent in the following categories:

- I. Exceptional Internal Communications This category recognizes examples of excellence in newsletters, flyers, brochures, electronic newsletters, or other projects designed to communicate with members, other faculty, and/or school administration. All entries must include an original or a copy of the material distributed along with an explanation of the projects, its intent, any results it produced, and a list of members responsible for its production. Entries for periodicals (e.g., newsletters) must include at least two consecutive issues. (Broadcast entries (audio and video) must be accompanied by a DVD or flash drive and should not exceed 8 minutes in length. Longer broadcasts should be edited to fit within the time limitation. Do not submit more than the required length.) Or, PDFs of the material or a link to an online copy may be provided.
- II. Exceptional External Communications This category recognizes examples of excellence in communicating with audiences outside of the local Association, such as the media, parent groups and/or the community in general. Projects would include, but not be limited to, newsletters, flyers, brochures, letters to the editor, op-ed articles, photography, or Internet homepages. Also, locals may enter total communications packages or media strategies. All entries must include an original or a copy of the material distributed along with an explanation of the project, its intent, any results it produced, and a list of members responsible for its production. Entries for periodicals (e.g., newsletters) must include at least two consecutive issues. Broadcast entries (audio and video) must be accompanied by a CD, DVD, or flash drive. Internet entries may include a hard copy of the pages or an Internet address. (Broadcast entries should not exceed 8 minutes in length. Longer broadcasts should be edited to fit within the time limitation. Do not submit more than the required length.) Or, PDFs of the material or a link to an online copy may be provided.

Special Communications Projects - This category recognizes examples of unusual communications efforts or large-scope projects such as total communications packages, media strategies or campaigns. All entries must include an original or a copy of the material distributed or a copy of the plan along with an explanation of the project, its intent, any results it produced, and a list of members responsible for its production. Entries for periodicals (e.g., newsletters) must include at least two consecutive issues. Broadcast entries (audio and video) must be accompanied by a CD, DVD, or flash drive. (Broadcast entries should not exceed 8 minutes in length. Longer broadcasts should be edited to fit within the time limitation. Do not submit more than the required length.) Or, PDFs of the material or a link to an online copy may be provided.

All entries should have been published, broadcast, or otherwise produced and executed between Jan. 1 and Dec. 31 of the preceding calendar year.

SPECIAL AWARDS:

Special awards may be presented at the discretion of the Communications Committee and/or the OEA Board of Directors for any project that is deemed extraordinary.

NOMINATION PROCESS:

Nominations will be accepted from any current officer of an active local affiliate of the OEA. Nominations must be submitted in accordance with the timelines for OEA Awards. Entries should be mailed to:

JUDGING:

The Golden Apple Awards will be judged by the OEA Communications Committee with the OEA Board of Directors reserving the right of final judgment of all awards. Entries will be judged on their own merits and not compared to other entries.

JUDGING CRITERIA:

- Does the entry meet the basic requirements of the Golden Apple Awards Program?
- How well does the entry meet basic standards of quality? (Is it well written, understandable, clear, concise, and/or logical in format? Spelling and grammar counts!)
- Does the entry meet the technical standards of the medium?
- Does the entry show imagination, innovation, uniqueness and/or creativity?
- How well does the entry promote the work of the local Association?

NEA FRIEND OF EDUCATION AWARD

PURPOSE:

Presented by the Board of Directors of the National Education Association, the award honors a person or organization whose contribution to the betterment of American education has made a significant national impact.

QUALIFICATIONS:

The Friend of Education Award may be bestowed upon any person or organization whose leadership, acts and support on the national level have proven that person or organization to be a true friend of education, educators, or students. An individual recipient need not be an American citizen, but they should reflect the philosophy and principles of the NEA. Individual nominees may be public or private citizens, and selection of finalists will be made regardless of age, sex, race, color, or creed. If an individual nominee is eligible for NEA membership, such membership is a requirement.

NOMINATIONS:

Any member of the National Education Association or a local or state Association may nominate a recipient by completing a nomination form which can be obtained from the members of the NEA Board of Directors, the Executive Committee, and state Associations.

SELECTION OF FINALISTS:

A screening committee composed of five members of the NEA Board of Directors shall review each nomination. The Committee shall submit its recommendation for the award to the Board of Directors for approval.

THE AWARD:

The Friend of Education Award shall be presented by the President of the NEA or the President's designee during the annual NEA convention, in a ceremony designed to place emphasis on the importance of the award.

DEADLINE FOR SUBMITTING NOMINATIONS:

The deadline for submitting nominations is April 1. Nominations should be sent to Office of Government Relations/Political Affairs, 1201 Sixteenth Street, N.W., Washington, D.C. 20036.

ELLISON S ONIZUKA MEMORIAL AWARD

Presented for leadership in resolving social problems, particularly as they relate to individuals of Asian and Pacific Islander heritage.

GEORGE I. SANCHEZ MEMORIAL AWARD

Presented for activities in Hispanic affairs that significantly impact education and the achievement of equal opportunity for Hispanic.

H. COUNCILL TRENHOLM MEMORIAL AWARD

Presented for leadership in advancing intergroup understanding within the education profession.

ROSENA J. WILLIS MEMORIAL AWARD (LOCAL)

Presented to the NEA local affiliate with the most improved human relations program.

APPLEGATE-DORROS PEACE AND INTERNATIONAL UNDERSTANDING AWARD

Presented for furthering the cause of international understanding: for serving as a model for youth and an inspiration in the quest for peace on earth; and for offering tangible evidence of the efforts to chart a course for world survival.

SUANNE BIG CROW MEMORIAL AWARD

Presented to a K-12 student whose achievements in school have helped enhance all students' sense of worth and dignity.

MARY HATWOOD FUTRELL AWARD

Presented for activities in the field of women's rights that have made a significant impact on education and have furthered the achievement of equal educational opportunity for women and girls.

CARTER G. WOODSON MEMORIAL AWARD

Presented jointly to the National Education Association and the Association for the Study of Afro-American Life and History (ASALH) for Leadership and creativity in promoting Black History Month, for furthering the understanding of Black Americans' heritage, and for making significant positive changes in a local community.

MARTIN LUTHER KING, JR., MEMORIAL AWARD

Presented for leadership and perseverance in applying the nonviolent philosophy and techniques of Martin Luther King. Jr., toward the achievement of human relations and civil rights goals.

AWARD FOR CREATIVE LEADERSHIP IN HUMAN RIGHTS

Presented for activities in the field of human rights that have made a significant impact on education and have promoted appreciation for diversity with regard to socioeconomic status, sexual orientation, disability, national origin, or citizenship status.

AUTHOR-ILLUSTRATOR HUMAN AND CIVIL RIGHTS AWARD

Presented to an individual whose books promote an understanding and appreciation of human and civil rights.

CESAR CHAVEZ ACCION Y COMPROMISO HUMAN AND CIVIL RIGHTS AWARD

Presented to an individual who follows in the footsteps of Cesar Chavez in philosophy, work, and leadership.

LEO REANO MEMORIAL AWARD

Presented to an individual whose activities have made a significant impact on education and on the achievement of equal opportunity for American Indians/Alaska Natives.

VIRGINIA URIBE AWARD FOR CREATIVE LEADERSHIP IN HUMAN RIGHTS

Presented for leadership in advancing intergroup understanding with the education profession.
