OEA Committee Descriptions

- **The Affiliate Relations Committee** is all about membership, developing strong locals and leaders, and reviewing zone alignment to assure one person-one vote.
- **The Budget Committee** reviews input, prepares and submits the OEA budget to the board of directors and the Delegate Assembly. The committee also reviews the association's annual audit.
- **The Collective Bargaining Committee** monitors state and national developments in collective bargaining, gives input on content for bargaining issues at conferences, works with the Legislative Committee on issues that impact collective bargaining, and recommends strategies that activate bargaining locals. Members also review and recommend winners of the OEA Collective Bargaining Award.
- **The Communications Committee** recommends strategies to enhance the public image of OEA and public education, develops lists of reputable media sources for members, discusses Read Across America activities, and helps create organizing strategies. Committee members also review and judge entries in OEA's Marshall Gregory and Golden Apple Awards programs.
- **The Constitution Committee** reviews the OEA Constitution and Bylaws and recommends appropriate amendments to the Board of Directors for action at Delegate Assembly, receives and reviews suggested amendments submitted by members and makes recommendations to the Board.
- **The Credentials Committee** provides oversight of appropriately elected delegates to Delegate Assembly as per Bylaw 5.3. Members of this committee may not serve as a delegate as they work during Delegate Assembly.
- **The Education Support Professional Committee** considers all things ESP, from work to organizing, to collective bargaining to professional development. The committee also recommends the annual winner of the association's ESP Award.
- **The Elections Committee** manages OEA Elections, from determining which order candidates appear on the ballot, considering any challenges to a race, and certifying the final results.
- **The Forces on Education Committee** takes a close look at all the groups and individuals who have an effect on public education, from the impact of privatization, the status of reform movements, and anti-union messages that have an impact.
- **The Human and Civil Rights Committee** works to increase ethnic and minority member input and engagement at all levels of education and association work and promotes where the OEA can help organize around H&CR issues. The committee also seeks nominations for four different awards, reviews nominations and recommends winners to the OEA board.

- **The Instruction and Professional Development Committee** provides input on professional development needs of certified and support members, reviews legislative changes and State Department of Education rules that may cause a need for professional development. It also reviews nominations for two Instructional Excellence Awards: Teachers Teaching Students and Teachers Teaching Teachers.
- **The Legal and Corporate Services Committee** considers and acts upon requests for legal services, working closely with our general counsel.
- **The Legislative Committee** develops the OEA Legislative Agenda, works with other committees on legislative issues, and recommends annual legislative goals.
- **The Member Benefits Committee** evaluates and recommends endorsement of products and services and reviews materials of member benefit products.
- **The Resolutions Committee** reviews and recommends changes and additions to OEA Resolutions, which are belief statements that help guide the work of the association.
- **The Standing Rules Committee** provides oversight of Delegate Assembly rules. This committee's members may not be delegates as they are working the Standing Rules Table during Delegate Assembly.
